The Dumb Friends League Pet Assist Program (the "Program") assists patrons in need of temporary placement for their pet animals ("Pet Animal") due to homelessness, situations involving domestic violence, and medical emergencies leaving the patrons unable to care for their current pets.

Pursuant to the terms of the Program, Patron hereby surrenders and transfers ownership of their Pet Animal, and the League hereby accepts and acquires the Pet Animal, subject to the terms and conditions stated herein.

### AGREEMENT BY PARTIES

#### I, Patron, and the League, agree as follows:

1. I am surrendering my Pet Animal. I understand that the League now owns the Pet Animal and I do not. I understand that this is a legal relinquishment under Colorado Revised Statute § 35-80-106.3.
2. I understand that the League now has total ownership, control, and decision-making authority over the Pet Animal. I realize that this means that they will make all decisions, including veterinary care, feed and care, fostering and housing, and all other matters. I also know that in some circumstances, like extreme pain or suffering, that these decisions could include euthanasia. I will not incur any fees for services provided under this agreement.
3. The League has not given me any guarantee or assurance that the Pet Animal will be available for adoption by me at the end of the Assistance Period. Nor has the League made any guarantee or assurance to me about any other outcome, treatment, or procedure.
4. It is my understanding that so long as the Pet Animal exists and is in good health, and I have complied with the timing periods in Paragraph 6 (Expiration Dates), the League has agreed to release and transfer ownership of the Pet Animal back to me at the end of the Assistance Period or within 24 hours of the Discretionary Discharge as set forth in Paragraph 7 (Discretionary Discharge), whichever is earlier. The transfer of ownership/adoption back of the animal will be at no cost to me.
5. If I want to adopt back the Pet Animal at the end of the Assistance Period, then I must contact the League no less than forty eight (48) hours before the end of the Assistance Period. If I fail to claim the animal at the end of the Assistance Period or within 24 hours after the League provides notice under Section 7 below, whichever is earlier, then I give up any right under this Agreement to try to adopt back the Pet Animal from the League.
6. I understand that the League, in its sole discretion, may at any time make the Pet Animal available



to me for release from the Program and for return and ownership transfer back to me. The League will provide me with 24 hours' notice.

7. This Agreement terminates at the end of the Assistance Period.
8. I represent and promise that the following are true:
  - a. I am 18 years of age or older at the date of execution of the Agreement and is the lawful owner, or duly authorized representative of the owner of the Pet Animal;
  - b. I have the authority to execute the Agreement;
  - c. No one has forced me to sign this Agreement;
  - d. To the best of my knowledge, the Pet Animal is in good health and is able to undergo any medical procedures and other surgery under general anesthesia; and
  - e. All information provided here is true and correct.

**PATRON'S RELEASE AND INDEMNIFICATION**

On behalf of myself, my heirs, personal representatives and assigns, I hereby release, discharge and indemnify the League, its officers, directors, employees, volunteers, and agents from any and all claims, causes of action and demands of any nature, whatsoever, whether known or unknown, arising of or in connection with the League's acceptance, care, treatment, housing, disposition or other action taken.

I know that the League often uses people or groups that are not affiliated with the League. Knowing that, I also agree, on behalf of my heirs, personal representatives and assigns, hereby release, discharge and indemnify those other people or groups and their officers, directors, employees, volunteers, and agents from any and all claims, causes of action and demands of any nature, whatsoever, whether known or unknown, arising of or in connection with this Program and the Pet Animal's acceptance, care, treatment, housing, disposition or other action taken.
